#### Type of action:

All users of the product and lot numbers listed above must follow the instructions described in the Actions section below before use.

**Description of the problem:** We have received a complaint where a product that should contain an Adult Ecolite<sup>TM</sup> Aerosol Mask with vents (Picture 1), has been found to contain a similar mask without vents (Picture 2), this would prevent the patient breathing normally. This could result in distress or some form of harm to the patient if unnoticed. It would also prevent the intended treatment being provided to the patient.

#### Action to be taken by the user:

Immediately quarantine all affected product codes and lot numbers listed above and do not use these devices. Please contact Intersurgical using the Response Form below to confirm these have been disposed of locally or arrange collection of the devices and credit.
