Dear Healthcare Professional,

We wish to advise you that <u>all in-date batches</u> of the products listed above are being voluntarily recalled with immediate effect.

This recall is being issued to **level of end-users**.

This action has been agreed with the Irish Health Products Regulatory Authority.

The reason for the recall is that microbial contamination was detected in number of product batches. This contamination can be a safety risk and can cause infections. All batches are being recalled as a precautionary measure.

We request that you perform the following actions:

- 1. Please immediately identify and quarantine any units of these products within your pharmacy. For hospital pharmacies or other such healthcare facilities, this includes units at wards, clinics and any other relevant locations within the hospital or facility.
- 2. If you have supplied packs of these products to any other pharmacy, hospital, clinic or other such establishment, please forward a copy of this recall letter to them, and request they quarantine and return any unused units to you.
- 3. Please return the quarantined stock to the wholesaler from whom you obtained the stock, or alternatively to the following: Vernacare Ltd, Matrix Park, 1 Western Avenue, Buckshaw Village, Chorley, PR7 7NB, United Kingdom. Please ensure that all units are returned to either your distributor or Vernacare Ltd. within 4 weeks of this notice.
