### Dear Valued Customer

As you may be aware, Becton, Dickinson, and Company ("**BD**") completed its acquisition of C. R. BARD, Inc., and its subsidiaries, including without limitation Bard Limited on December 29, 2017, and C.R. Bard became an owned subsidiary of Becton Dickinson. Because of the nature of the transaction, the integration of C.R. Bard into BD is a gradual process that has been happening over a period of time.

BD is now preparing for the next phase of integration. **ALL BARD\*** products previously purchased from Bard Limited are becoming product lines offered by BD and will be fully integrated into BD operations and supply chain.

Attached to this communication (schedule A), you will find a list of BARD products which will not be subject to this transition (PleurX Product Lines). These will still be purchased from Bard Limited.

As part of this journey, BD is deploying a large-scale, multi-year investment to transform our systems, processes and supply chain eco-system to provide a best-in-class Customer Experience for you and the patients who rely on our products & services. As such, we're investing in additional people resources to enhance our customer service, distribution and logistics teams to better support you through the upcoming transition period.

While we undertake this integration journey, we are leveraging our expertise built through a 125-year legacy of making critical technologies to also navigate and mitigate the unprecedented supply chain disruptions impacting us and many companies around the world. We remain committed to delivering the highest level of quality, transparency and continuity as we work in close partnership with our customers, suppliers, transportation providers and government stakeholders so healthcare providers can continue to deliver uninterrupted patient care.

In line with our commitment to transparency, please be aware that the following key changes will take effect with the Bard transition on Friday, July 1, 2022:

### • BD legal entity

Bard Limited product lines are offered by BD and your orders should be addressed and will be fulfilled by the BD legal entity\* excluding PleurX.

The BD entity will continue to maintain the effective Quality Management system, certified to ISO standard, which is currently in place, to serve our customers through implementation of customer-focused procedures and continuous improvement.

## • Contracts & Agreements

If you are currently purchasing from Bard Limited under Tender contracts, service contracts or special price agreements, <u>ALL</u> your contracts & agreements for BARD products (excluding PleurX), will be automatically transferred to BD by **July 1<sup>st</sup>, 2022.** Please return your signed novation documents by **June 20<sup>th</sup>, 2022.** 

## • Ordering schedule

Purchase orders placed to Bard Limited before **Wednesday**, **June 29**<sup>th</sup> with an effective delivery date before **July 1**<sup>st</sup>, **2022**, will be fulfilled by Bard Limited.

### • Unfulfilled and Future Dated Orders

Any **unfulfilled & future dated purchase** orders for Bard Limited products and services, placed before July 1<sup>st</sup> 2022, will be automatically transferred, and fulfilled by BD.

Between  $29^{th}$  June and  $1^{st}$  July **no orders** will leave our distribution center while we transition to our new ERP system.

### New orders

Purchase orders for Bard Limited products and services generated as of **July 1<sup>st</sup>, 2022**, **onwards** should be addressed to Becton, Dickinson U.K Limited and placed with our Customer Service using one of the contact methods shown above.

Please **update** your systems as necessary in preparation for the integration to include BD as supplier for Bard Limited products and services. Information you may need to update your systems is provided on (schedule C) to this letter.

If you already have a BD account for purchasing other BD products please use this for ordering Bard products\* excluding PleurX.

### • Shipments

All shipments for BARD products will **continue** to be shipped from our Distribution Center in Olen, Belgium. BD products will **continue** to be shipped from the BD distribution center from which they are currently shipped.

Freight charges will be aligned with BD as of July  $1^{st}$  2022.

## • Open invoices

ALL **open** Bard Limited invoices as at 1st July will be handled by BD and shall be **paid** to the BD bank account mentioned below. A confirmation Letter from BNP Paribas is provided on (schedule D) to this letter. Payment terms will be aligned to BD UK's which is currently 30 days net.
