Reason for Field Safety Notice

This notice is issued to inform users that whilst the primary packaging of the batches of syringes listed above is orange, the printing of the barrel is black. Only the batches listed above are affected.

This is not in line with our specification for this product. However, the graduation markings on the syringe accurately display measurements suitable for insulin administration (units), aligning with insulin dosing requirements. This notice is to highlight to users that extra care should be taken to ensure that syringe graduation markings with 'units' not 'ml' should be used to administer insulin, and that this should always be checked prior to administration.

This notice aims to ensure transparency and uphold our commitment to maintaining product quality and safety standards.
