Dear Össur customer,

Össur is conducting a Medical Device Recall of the above Miami J Select devices.

The potentially affected device has been supplied to your organization.

#### **DEVICE ISSUE**

It has been identified that the pressure sensitive adhesive (PSA) hooks attached to the sides of the anterior collar panel can occasionally exhibit poor adhesion, which may lead to them gradually peeling off with repeated doffing, possibly leading to reduced immobilization of the cervical spine. These hooks attach to straps on the posterior panel of the collar.

No immobilization issues or injuries associated with this fault have been reported to date.

To ensure compliance we are initiating a device recall of all Miami J Select collars with lot numbers ranging from MX220516 to MX230104, sold in the period of 2022-05-19 to 2023-06-05. The affected lots are outlined in Appendix A at the end of this notice.

The required actions in relation to this case are outlined below:

### **ACTION - ORGANIZATIONS**

ACTION REQUIRED: Please examine your inventory, quarantine devices subject to the recall, and return the Customer Acknowledgement Form to the email address listed on the form. A return authorization will then be provided to return the device to Össur.

Recipients of this notice should take the following actions:

- Please pass this notice to those who need to be aware within your organization or to any organization where the potentially affected devices have been transferred.
- Maintain awareness on this notice for an appropriate period.
- If you have further distributed this device, please identify your customers, and notify them at once of this recall. We recommend that you include a copy of this recall letter.
- Ossur recommends healthcare professionals perform a detailed inspection of the device to verify lot number, and to ensure structural stability for any patients' currently wearing impacted device.
- If any of your customers are currently wearing a device, the packaging label should be inspected for the lot number:
  - If the lot number is outside of the affected range, no actions need to be taken.
  - If the lot number is inside the affected range, healthcare professionals are advised to assess whether a removal and replacement of impacted device currently in use is warranted on a case by-case basis.
  - If the packaging label/lot number is not available, healthcare professionals are advised to assess whether a removal and replacement of the impacted device currently in use is warranted on a case-bycase basis.
- Complete and return the attached Customer Acknowledgement Form to the email address provided.
