In this Field Safety Notice (FSN) we'd like to inform you about a voluntary Field Safety Corrective Action (FSCA) related to NIHON KOHDEN recording paper models *NKUK-A054* and *NKUK-MLSC-125* for Electrocardiographs.

This FSN shall:

- describe the identified non-conformity in the labelling,
- inform about potential risks associated with the use of these non-compliant products, and
- describe the corrective action plan.

Based on our product tracking we found that we have delivered at least one set of the non-conforming recording paper to you.

The non-conforming recording paper can be identified by the labelling on the packaging easily.

Affected products:	Recording paper, models:	NKUK-A054 (210mm, grid, Z-fold) NKUK-MLSC-125 (110mm, grid, Z-fold)
Description of the non- conformity:	It was determined that the recording papers do not meet the regulatory requirements for the labelling of medical devices. However, there is no restriction in the intended use, technical specification, manufacture, function, performance or safety of the recording papers. The non-conformity relates exclusively to the labelling.	
	NIHON KOHDEN UK Ltd. falsely marketed the recording paper under its own name, although NIHON KOHDEN UK Ltd. is not the actual manufacturer of the recording paper. This has created the impression that NIHON KOHDEN UK Ltd. is the manufacturer of the related recording paper. The company Nissha Medical Technologies Ltd. is the actual manufacturer of the recording paper and has offered and provided us with customised branding for these recording papers. Due to an internal misunderstanding regarding the associated responsibilities, we started marketing these incorrectly labelled papers in April 2020.	
Potential risk:	There is no risk to patients or operators or for documenting/archiving purposes if the incorrectly labelled recording paper is used.	
Corrective action:	recording papers. From now on, NIHON KOHDE correct labelling of the actual r	as stopped the delivery of the incorrectly labelled EN UK Ltd. will deliver the recording papers with the manufacturer. rding papers therefore change as follows:
