



URGENT FIELD SAFETY NOTICE

Farla Medical are issuing this recall notice to inform you of a product recall involving all detailed lots of the below mentioned product list (Appendix 1).

Our records indicate that you may have purchased this product, and this letter requires your immediate attention.

DESCRIPTION OF THE DEFECT

This notification is issued in response to the release of medical devices into the UK market by Farla Medical, which were manufactured by an external subcontractor. Unfortunately, the sterility and performance of these products cannot be assured. It has come to our attention that the subcontractor may not have adhered to the required regulatory oversight, resulting in potential non-compliance with the essential safety and performance standards outlined under UK Medical Device Regulations.

While no immediate adverse events or customer complaints have been reported, the deviation from regulatory requirements means that the quality and performance of these products cannot be fully guaranteed. In order to mitigate any potential risks, Farla Medical Ltd is taking immediate corrective action to remove the affected devices from the market and prevent any further distribution.

ACTIONS TO BE TAKEN BY FARLA MEDICAL

Farla Medical Ltd has initiated an investigation into the cause of the issue with the subcontractor and will put corrective actions in place to ensure future products are not affected.

ACTIONS TO BE TAKEN BY THE CUSTOMER

We request that you check your inventory for the items within the scope of this recall notice, and if you have the items identified please cease use and distribution of the stock and quarantine immediately.

Please ensure that other relevant staff in your organisation are aware of this issue. Please maintain awareness of this notice and resulting action for an appropriate period to ensure effectiveness of the corrective action.



If the affected product has already been safely used, then no further product-related action is required.

Please promptly return the attached Recall Acknowledgement Letter & Form (QPD-29 -Iss. 7.0) to acknowledge receipt of this Notice.

Please note, if the Recall Acknowledgement Letter & Form (QPD-29-Iss. 7.0) along with the affected product is not returned within 21 days from the date of this notification, Farla Medical Ltd., must proceed with the closure of the corrective action involved. The deadline for return of the affected stock is the 24th of May 2025. After this date it will not be possible to replace the affected stock
