

NHS Supply Chain Insulin Pumps, CGM's and Associated Products - Framework Reference Number: 2021/S 000-014257

Key Features

- This is a direct framework; once a trust has signed up to purchase from a supplier, all ordering, invoicing, deliveries will continue to be managed directly with the supplier.
- This framework captures all the suppliers and technologies available at the point of launch. However, it will not prevent new suppliers and products coming to market from accessing the NHS.
- 3 Lots and 15 suppliers are available at point of launch (summary below).
- The unique structure of this framework has the provision to reopen every 12-months. Following the completion of the first reopening of the framework TLB Medical Supplies has been added to the framework.

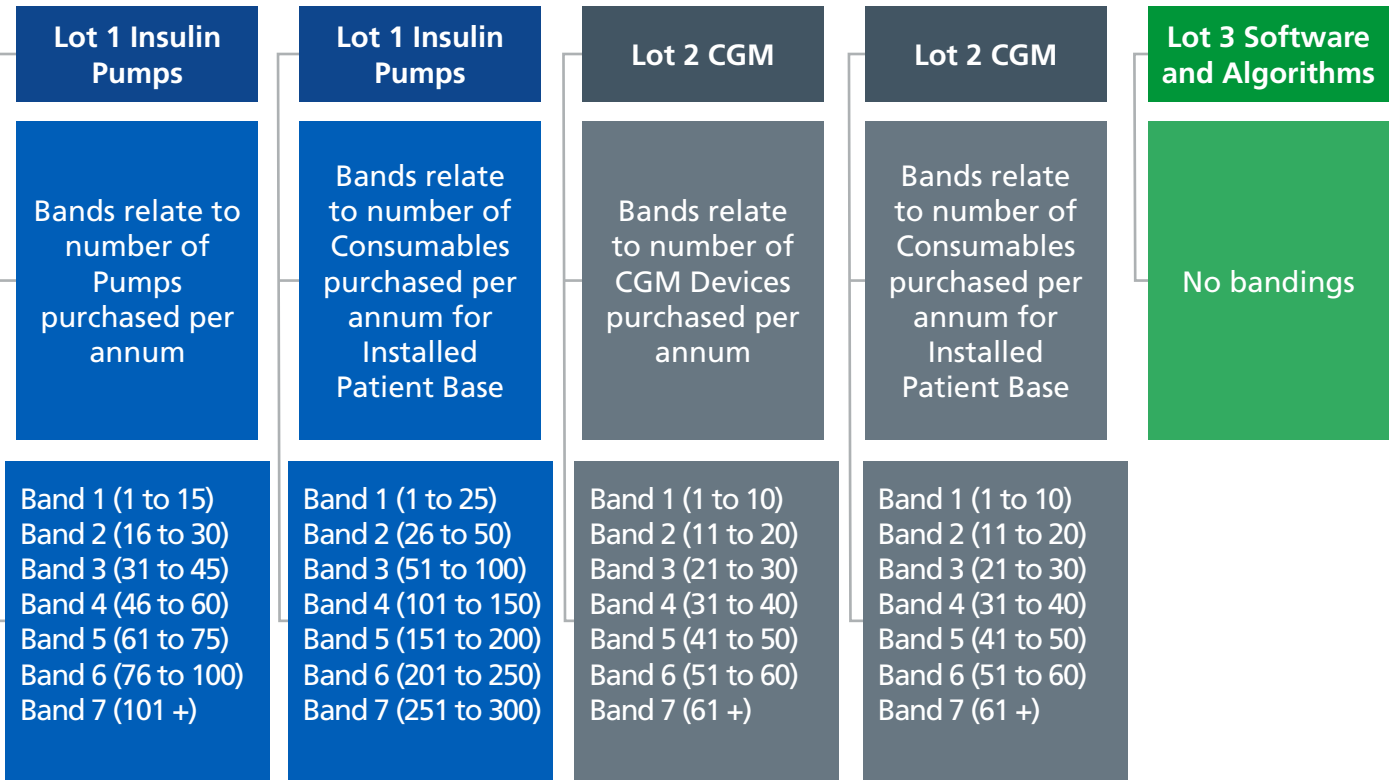

Key Changes

- The sign-up procedure has changed (see flowchart), we will no longer be issuing a Memorandum of Agreement (MOA). Instead, we will issue a Unique Reference Number (URN), which can be flexible to suit the trust requirements in terms of how each trust manage their budgets. For example, some suppliers have banded prices which are reviewed on a 12-monthly basis, so some trusts want a new URN every time they have a change to their price band. Other trusts want the URN to run for the financial or calendar year, or for a specific quantity, specific value or indeed be open ended, (i.e. for the duration of the framework).
- Following the completion of the first reopening of the framework TLB Medical Supplies have been successfully awarded to the framework.

- The information contained within the URN form will ask for details around hospitals that belong to the trust and the name of the procurement personnel at the paying trust. The URN form will also contain your pricing information, but we will not require any signatures. The URN form can be requested from the Buyer, Leigh Carr.
- There is a change to the banding structure, moving from four price bands to seven price bands. The banding structure has been changed to reflect the type and usage of product i.e. devices or consumables.
- New Lot added **“Software and Algorithms”** to enable supplies of the most up to date technology to be able to bid on and be awarded to the framework.
- The framework will **reopen on a yearly basis** to allow any new supplier in this field to be able to join the framework and to also allow any suppliers already awarded to the framework to add any new products in lots that they are not currently awarded to. No suppliers will be removed from the framework when reopened.
