- Focus on how NHS Supply Chain engage with NHS partners through the Care Pathway team, through resilience/alternatives and via the Voice of the Customer Category Strategy programme. More work underway to enhance this, especially in relation to how we can share new care pathway opportunities of innovative products and novel ways of using existing products and medical devices.
- 2. Focus on the value of clinical procurement expertise and how we are working collaboratively with NHS trusts Clinical Procurement Specialists and NHS Supply Chain clinical community to develop this further. Some key research now available via your regional representative.
- 3. Focus on patient safety and how we ensure that we prioritise our clinical engagement on products and medical devices which could cause the most harm. This includes how NHS Supply Chain undertake clinical and quality assessments of products which could include product and device sampling. This topic will be discussed further at a future meeting.
