Medical IT Framework and What We Offer

Framework Overview

- The current Medical IT Framework Agreement runs from 1 February 2021 to 31 January 2025.
- Offers the NHS a fully OJEU compliant route to purchase Medical IT software and hardware solutions, either through a Direct Award (Call off) or a full pricing exercise.
- Enables the NHS to specify and create fully bespoke clinical IT solutions across single or multiple departments, sites and trusts.

Benefits of using our framework

Documentation Suite - A full suite of template documentation to support you through each stage of the procurement process. Statement of Requirements templates and Contract documentation, as well as process plan, implementation timelines and evaluation templates are provided, alongside process support from pre-market engagement through to contract award.

Dedicated Support - The Medical IT team along with support from our customer facing account managers will work closely with the trust/boards to ensure all the procurement activities are performed in line with the procurement timelines.

Departmental Solutions - Such as Radiology Information Systems (RIS) and Picture Archiving Communication System (PACS) solutions for multiple departments such as Radiology and Cardiology.

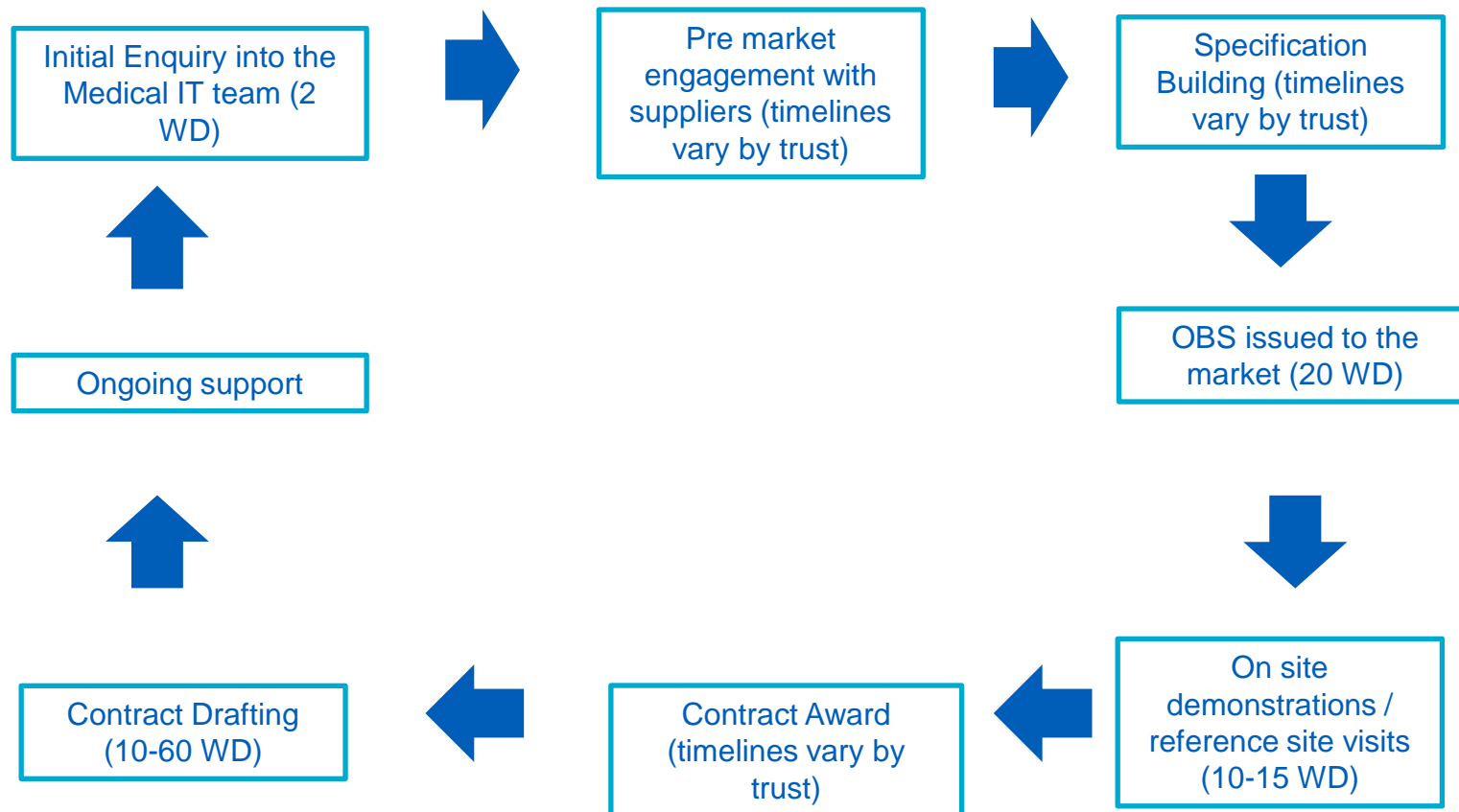

Supporting Documentation

- At point of call off, trusts and suppliers are required to agree a contract using the relevant framework order form. The team will support and advise on the relevant documents required to support your procurement activity. Suppliers will also use copies of this documentation:
 - **Managed Services Contract (MS CON Order Form (General) / Systems Services Contract (SYS CO) Order Form General**
To be used for general system deployments which include hardware.
 - **Managed Services Contract Picture Archiving Communication Systems and Radiology Information Systems (MS CON PACS and RIS Order Form / SYS CON PACS and RIS Order Form)**
To be used for PACS and RIS requirements specifically which are to be deployed on premise and include hardware.
 - **Software as a Service (SAAS Order Form and Terms MS CON Terms)**
This template should be used only where a cloud-hosted software solution is being procured ('Software as a Service' or 'SaaS').
 - **SAAS Terms and Conditions (E-Direct Only)**
These are in the most part fixed terms for use with products added to our e-Direct Online catalogue.
 - **On-Premise Software Order Form and Terms (SYS CON Terms)**
This template should be used only where a software solution which sits on the customer's hardware is being procured (known as 'on premise' software).
