 Demand management has been / will imminently be removed from all remaining GOJO stock.

 We continue to meet with the suppliers each week to ensure installations are being progressed and to support on any issues.



## **UKHSA: Influenza Positivity**




#### 21 November 2025

Figure 4. Percentage of tests positive for influenza among all reported influenza tests, England [note 4]




#### 5 December 2025

Figure 4. Daily percentage of tests positive for influenza among all reported influenza tests (7-day rolling average), England [note 4]




The 2024 / 2025 influenza wave was significant vs previous years and spread swiftly, putting a strain on NHS resources. Several trusts reverted to pandemic-era practices to protect staff and patients.

As the wave spread, so did demand for PPE, and NHS Supply Chain took non-standard measures to respond and support trusts.

#### **Demand vs Previous Years**





Winter Period (November – January)	Type IIR Masks (millions)
2020 / 2021	159.7
2021 / 2022	180.4
2022 / 2023	127.6
2023 / 2024	50.3
2024 / 2025	43.3

Demand for Type IIR masks has dropped significantly post COVID.


During November 2023 we were using ~4 million masks per week. This had reduced below 2 million masks per week by November 2024.

Whilst overall usage was comparable to previous winter, the 'flu positivity rates were comparable to winter 2022 / 2023.

The concern was that order volumes could rise to match those levels: ~8 million per week.

## **Demand: Type IIR masks**





We saw some isolated spikes in November as trusts placed large orders, having burned through stockpiles created during 'Free PPE'.


The influenza wave spread swiftly during December, and it became difficult to differentiate 'flu demand from festive stock build demand.

The prudent response was to step out of BAU processes:

Daily calls were initiated Tuesday 17 December and additional stock was purchased from framework suppliers.

## **Demand: FFP3 Respirators**





Demand was relatively stable during October and November:  $\sim 70,000$  respirators per week (14,000 per day). This was a step up from the  $\sim 45,000$  per week seen through summer and into September.

Real uplift in demand was Thursday 19 December, when 34,524 x FFP3 were ordered. (Same date as Type IIR uplift). Again, we were attempting to differentiate exceptional 'flu demand from standard festive stock build demand. Additional stock was purchased from framework suppliers to ensure continued availability of product across the portfolio.

#### **Demand: Peak Week**






Aside from 3M, we also saw daily demand treble, across a range of respirators during the week commencing 16 December.

Whilst we knew there was an element of pre-festive stock build, we felt it prudent to secure additional supplies.

## **Demand: FFP3 Respirators**





Total Forecast:\* 1.0 million Actual to date: 1.2 million

Prev Year: \* 1.5 million


\* Same 11-week period 18 November to 27 January.

Demand was close to forecast until the week commencing 16 December, when it started to diverge. The peak we saw week commencing 13 January was substantially above forecast.

We had by then procured additional stock from framework suppliers to ensure continued availability of products across the portfolio.

### **Demand: 3M 1863+**






Demand for the key 3M respirator, 1863+ was in line or below forecast until week commencing 6 January, when we saw a sizeable uplift.

It has since returned to below forecast as the impact of the 'flu wave has passed its peak.

We forecast 440,260 of the 1863+ respirators would be ordered: thus far we have used 451,380.

### **Demand: Resilience**





We remain heavily reliant upon 3M for respirators (51% of demand).

Please do assist with resilience by ensuring staff are fit-tested to multiple masks.





## **FFP3 Blended Pricing**

## FFP3 Blended Pricing - Reversal



- Following repatriation of push stock model, FFP3 masks (valved and unvalved) stock was blended whilst market reverted to Business As Usual (BAU) and to support resilience principles of NHS England (NHSE).
- Following customer feedback regarding pricing, we are looking to reverse out the blend.





## **Examination Gloves Stock Position**

## **How the Supply Chain Operates**




#### 1 Transferred Stock

577 million products from the stockpile are transferred to NHS Supply Chain RDCs for immediate use.

Current stockpile is 99.5% GN90 with some NX435.

#### 4 Replenish Stockpile

NHS Supply Chain are placing new orders for GN91, which are currently replenishing the pan prep stockpile volumes (i.e. 577 million).



#### **2 Customer Orders**

Customers order from their existing stocked codes/product families available (i.e. GN91 / GN90 / HAIKA / NX435).

#### 3 Transition to Alts

Once the customers current stock codes run out of stock, customers are required to move to the **direct alternative** available from the stock profile. These are set up on the system.

For assurance, we can supply national demand but customers must move across to the next direct code to support rotation.
