

Indication(s) for use:	Film Island dressings consist of a standard film dressing with an incorporated absorbent pad. The dressing pad improves fluid management through absorption but obscures visualisation of the wound bed.		
User instructions:	Included within product packaging

Features and [Clinical] Benefits

The key features were identified as:

Film and Film Island Dressings:

- Expected wear time of at least 48hrs, although this may be longer depending on clinical conditions.
- Use of latex discouraged in products and packaging, where this is present it must be clearly labelled.
- Ensure product packaging can be reliably opened using intuitive non-touch aseptic technique (ANTT).
- Minimum of 18 months shelf life to aid stock management and reduce waste.
- All products must include clear easy to follow instructions for use, to reduce waste and errors.
- Working with awarded suppliers over the next two yearss to ensure these instructions are included on each individual dressing, not just on or with a box.











Film Island Dressings only:

Film Island dressing include all the benefits highlighted for film dressings. In addition:

- The absorbent pad must be able to manage at least low levels of wound exudate absorbency has been standardised across the frameworks as referring to total fluid handling capacity as per BS EN 13726-1, with the following thresholds;
 - Low 0.01 4.99 g/10cm2
 - Moderate 5.00 9.99 g/10cm2
 - High 10.00 24.99 g/10cm2
 - Ultra High =>25.00 g/10cm2
- This standardisation of absorbency is key to ensuring all dressings can be labelled and discussed by clinicians in a comparable way moving forward.
- The absorbent pad must be covered by an adhesive border that can adhere to and seal around the peri wound skin. The absorbent pad must remain intact in use, on removal and be non-linting.

Compatibility

These products are standalone products and can be used entirely independently. Film and film island dressing have a wide range of potential uses in the hands of an appropriately trained clinician. If you are concerned a dressing is incompatible with other devices, please seek clarification from the manufacturer or NHS Supply Chain.

Stakeholder Engagement

To determine NHS informed criteria we have engaged with an extensive range of key stakeholders from a wide geographical spread and different areas within NHS settings, this included national engagement at various Acute Hospital Trusts, Mental Health Trusts and Community Trusts, along with National Wound Care Strategy Programme, Specialist Networks and Wound Care Charities in conjunction with the Clinical Evaluation Team (CET) Report.











Evaluation

- The specification has been built using a strong user input with numerous stakeholders from over 100 NHS Organisations including Acute, Community, Mental Health and Ambulance Trusts. Representatives from National and professional bodies have also been involved
- The specification has been built using
 - Key product information
 - Technical information
 - Functional features
 - Product attributes
 - Human factors
 - National & International standards
 - National Guidelines / professional guidance
 - Best practice
- All products were evaluated by a range of measures, including laboratory testing and 'hands-on-product-assessment' by clinicians and met the following criteria:

Be suitable for use on both unbroken skin and superficial wounds.

Stated to be showerproof/wipeable or waterproof.

Assured as safe to leave in place for up to two days depending on the clinical circumstances.

Be designed to minimise pain and trauma on removal.

Range must meet each of the core size requirements:

6cm x 7 - 8cm

12cm x 12 - 15cm

10 - 15.5cm x 20 - 25cm

Must be supplied sterile and individually wrapped

Have a non-adhesive tab to allow opening with an aseptic, no-touch application technique (ANTT) on any individual packaging.

Product must include instructions for the application of the product, this can be provided on the product itself, the product packaging, or within the instructions for use document, provided within the product packaging.

The instructions can either be diagrammatical, pictorial, numerical or in text form.

Absorbent pad is covered by an adhesive border that can adhere to and seal around the peri wound skin;

Must be fully transparent (to be visually able to see the skin after application - in areas where the absorbent pad is not present)
