## Indications for Use

This competition is for a range of products that are covered under Lot 1 – Medical Pulp Products of the current framework. These include maceratable toileting products, receptacles, and a pulp tray. Customers should ensure they consult relevant departments, such as infection control, if required.

## Sustainability

Medical Pulp is made from either or a mixture of over issued newspaper and kraft cardboard which has already been recycled several times from virgin pulp. As Medical Pulp, the raw material reaches end of life once it is macerated and disposed of. This category is a strong example of materials being used sustainably.

There are no single use plastics in this category.

## Benefits

This NCP has been dual sourced for each product line, currently sole award, to increase supplier resilience. Also, all participating suppliers are required to provide assurance of their capability to fulfil national volume requirements.

If the NCP had not been renewed and framework pricing had been implemented, a national cost pressure of approximately £2.8 million would have been realised. The procurement exercise has however, been able to mitigate the national cost pressure down to £1.3 million. With this NCP the NHS will still save money in comparison with 2018 to 2020 Medical Pulp product pricing.

The price increases are minimised from the rises in energy prices which the supplier base has kept us informed of and Mintec indices support. To help mitigate the price increase, we have introduced a Cost Adjustment Mechanism to review prices quarterly for raw materials and energy costs. Due to having to undergo this procurement in the middle of market increases we anticipate there to be reductions over time.

## Compatibility

All products are the same shape and size as the current products. Where products are used with a slipper pan or support the new products will fit. Should Trusts wish to obtain samples contact NHS Supply Chain who can arrange for samples to be sent.



## Evaluated By Organisations

All pulp products in scope were reviewed by customers (with the exception of pulp trays). Trusts ran trials using the products in a ward-based setting or conducted a tabletop review.

The trusts that supported these trials were; University Southampton NHS Trust, University Hospital Plymouth NHS Foundation Trust, Doncaster & Bassetlaw Teaching Hospitals NHS Trust, University Hospital NHS Foundation Trust, Countess of Chester NHS Foundation Trust, Leeds Teaching Hospitals NHS Foundation Trust, Manchester University NHS Foundation Trust.

Wrightington, Wigan, and Leigh Teaching Hospitals NHS Foundation Trust, are the Lead Reference Trust for the Pulp framework.

## Frequently Asked Questions

### How was this competition evaluated?

Products were evaluated as part of a ward-based trials or tabletop review to ensure the products met the framework specification and needs of the NHS. Suppliers provided evidence that they met PAS 29:1999. We were then able to evaluate on 100% on price.

### Will my products change from Vernacare?

For some product lines you may receive a different product. The product will meet the same specification as your existing product in terms of weights, dimensions. The only difference you may notice is the MPC code on the packaging of the product.
