

Nationally Contracted Products (NCP) procurement outcome:

NCP Pressure Infusers procurement activity forecast to achieve 8% (£57,000)* national savings opportunity



Summary

The current framework offered a sole award NCP, with Bluebox Medical and as part of the September 2022 framework renewal Disposable Pressure Infusers are moving to a dual award NCP offer.

Disposable Pressure Infusers are part of the NCP offer which will now be a dual award so each product line will have two options, please see below for the breakdown. The aim of the dual award is to gain supplier resilience and offer a rationalised range of high-quality products. All products have been through an internal HOPA (hands on product assessment) and external testing with SMTL (Surgical Material Testing Laboratory).

We expect to achieve savings as the current supplier is holding prices and there is a cheaper alternative on the dual award.

The new framework has mitigated potential cost pressures for the NHS as the existing products are available at the current framework price. Further savings are available, should customers switch to the alternative supplier. Please request samples from your Clinical Nurse Advisor.
