

Nationally Contracted Products (NCP) procurement outcome:

Three Panel Knee Immobilisers

NCP procurement activity achieves 27% (£138,000)* national savings opportunity



Summary

This NCP procurement exercise was undertaken for Three Panel Knee Immobilisers.

The aim was to rationalise the number of suppliers and products, create savings through consolidating volume, and to aggregate national demand to provide a sustainable competitive price for the NHS.

This has been achieved by awarding to two suppliers (including the market leader) and rationalising down to nine product lines.
