# Key Messages- November 2025

1. Early notification - New NHS Supply Chain Sustainability Strategy coming, when it is launched can it be shared with regional CNO/CMO and teams - opportunity to consider within regional/ICS green plans - four key objectives

## **Achieve Net Zero Emissions**

Focus on reaching Net Zero carbon emissions by 2045 through supplier engagement and logistics transformation targeting Scope 3 emissions.

## **Promote Circular Economy**

Phase out avoidable single-use MedTech products by 2045 following circular economy principles to reduce waste and improve reuse.

## **Maximize Social Value**

Enhance social value via procurement emphasizing fair work, health equity, and engagement with small and medium enterprises (SMEs).

## **Ensure Ethical Supply Chains**

Mandate Carbon Reduction Plans, Evergreen assessments, and Modern Slavery compliance for transparent and ethical supply chains.

2. To leverage the clinical quality assessments of products within frameworks to: Reduce duplication in local evaluations of safety, clinical effectiveness, and care experience. 3. **NHS Supply Chain Clinical Advisory Forum – Terms of Reference Update**

The Terms of Reference will be amended to include a key objective: To work collaboratively as an advisory forum, providing critical thinking and constructive challenge to test NHS Supply Chain strategies. To act as a conduit for key messages from NHS Supply Chain to regional Chief Nurses, Chief Medical Officers, and their teams, enabling the rapid dissemination of learning and opportunities at pace and scale.
