

## eDC Web Application Release Notes

## What's New?

In response to customer feedback, we regularly work on various bug fixes and performance improvements for our eDC web application. Below are the latest updates being released.

## eDC

- Local Catalogue A warning will now appear when changes are made within the Supplier dialogue box and when the "X" is used to close. (EDC-395)
- Requisition Report (PDF and Excel) Username added to the order header of the user who processed the demand. (EDC-1334/1335)
- Global Edit Fixed a server error when a report is generated for a Req Point belonging to a different Warehouse from where the selected MMD is situated. (EDC-1353)
- Global Edit Fixed a server error when processing a scaled product, resulting in a value above the maximum allowed re-order level. A proper error message is now shown. (EDC-1370)
- **New enhancement:** Now able to mass select the Authorisation tick boxes using the tick box in the table header. (EDC-510)
- Fixed various validation bugs within the Local Catalogue bulk importer. (EDC-813)
- Fixed the pagination resetting to 10 after clicking search in the Catalogue screen. (EDC-1174)

## eDC Gold

- Order Status Report PDF version The NPC and MPC now properly wrap if they are too long. (EDC-1173)
- Transaction Report PDF version The NPC and MPC now properly wrap if they are too long. (EDC-1244)
- Barcode Imports The GS1 barcode type has been fixed to prevent letters from being accepted. (EDC-1198)
- The transfer screen is fixed so that it no longer shows which destination store is the same as the sending store. (EDC-1240)
- Stock Status Report PDF version No longer shows batch lines for batches previously in stock. (EDC-1256)
- Stock Status Report PDF version Long MMD names are no longer cut off. (EDC-1345)
- Changes made to improve performance when duplicate serial number checking. (EDC-1262)
- Fix to prevent duplicate Put Aways from being created when importing serial-numbered receipts from Android devices. (EDC-1301/1331)



- On the requirement summary screen, fixed where if filtering by Req Point on an empty / new Req Point, the Req Point wouldn't show, even if Display All was selected. (EDC-1361)
- Fixed an issue on the Global Edit screen, and using Quick Add to add products, not all Req Points would be listed that have those products assigned. (EDC-1374)
- Stock Take Report: Removed lines that only contain zero. (EDC-1404)
- Fixed the issue where various screens would go out of alignment (depending on browser zoom level) (EDC-1430)
- Increased the limit for a Pack Size in the Local Catalogue to 32,500 (from 10,000). (EDC-1436)
- Stock Definition edit item information warning now correctly includes that the Issue UOM cannot be changed. (EDC-433)
- Fixed the default store warning days indicator below the removal if there is an error on saving on the Stock Definition screen. (EDC-437)
- Fixed single active Store not being selected if other Stores within the Site are inactive (EDC-439)
- When receipting in a serial number that already exists within the MMD, the failed transaction log will now show the correct store the serial number is located in. (EDC-973)
- Fixed the copy record option not being able to be processed in the Issue screen, due to an apparent invalid quantity. (EDC-1163)
- Removed the superfluous ">>" button from the Receipt screen. (EDC-1181)
- Fixed the Barcode import failure screen, which never showed any failures. This screen will now populate when a conflicting barcode is uploaded, giving the user the option to overwrite the original or ignore the new assignment. (EDC-1185)
- In the Planned Receipts, fixed an issue where copying would toggle the Mark as Complete option on and off. (EDC-1186)
- Fixed the issue that prevented the ability to search for descriptions in the Return to Stock screen. (EDC-1187)
- Stock Definition importer is now less likely to timeout with an Ajax error. (EDC-1194)
- Inserted a notification message on the Issue screen to indicate that personal data should not be input into free-text fields (data protection reasons). (EDC-1438)
